



# AVOID UTILITY SCAMS

very day, millions of Americans are targeted by scammers through phone calls, emails, text messages, online or in-person. Scammers' tactics can change daily, which is why it's important for consumers to stay on top of the latest scam reports.

In the past few months, we've received reports of Scenic Rivers Energy Cooperative (SREC) members being targeted through a phone scam known as the overpayment trick, where a scammer contacts you and claims that you have overpaid your utility bill. The scammer will say they need your personal banking information or your debit/credit card information to deposit the credit back to your account. Don't fall for this scam! If you make an overpayment on your energy bill, SREC will automatically apply the credit to your account, which will carry over to your next billing cycle.

We want you to be aware of two other trending scam tactics. One is the disconnection threat where the scammers demand immediate payment and threaten to shut off power if the money is not received. Remember, SREC will never call you and demand immediate payment without notice. Another trending scam is smishing (short for SMS phishing). Many consumers know to watch out for suspicious emails, but we tend to trust text messages. Always question suspicious texts, especially from someone claiming to represent a utility. Scams like these are becoming increasingly common, so staying vigilant is essential.

# Watch for the Following Red Flags

- High-pressure tactics that demand urgent action.
- Unusual payment method requests (wire transfer, gift cards, reloadable cards or cryptocurrency).
- Poor grammar, misspellings and suspicious email addresses.

# PROTECT YOURSELF FROM UTILITY SCAMS



#### Take Control of the Situation

Here are a few reminders on how to take control of the situation when you've been targeted by a scammer:

- Take your time. Utility scammers try to create a sense
  of urgency so that you'll act fast and hand over personal
  information, especially over the phone. Take a moment
  to think about the situation before acting.
- Be suspicious. Scammers typically request immediate payments through prepaid debit cards or third-party apps. Unusual requests like this should raise red flags. Remember, if the request seems strange and out of the ordinary, you're likely being targeted by a scammer.
- Never share personal information. Legitimate companies won't ask for sensitive details over the phone.
- Request identification. If someone claims to be a
  utility worker, request official identification. SREC
  employees will be in a marked vehicle and have photo
  identification that they can provide upon request. If
  you're in doubt, call our office and we can confirm
  whether or not it's our crew.
- Confirm before you act. If you receive a call from someone claiming to represent SREC or another utility but you're unsure, just hang up the phone and call the utility directly.

### Eligibility and Qualifications

To be eligible to receive a scholarship, the applicant's parent(s), legal guardian, or applicants themselves must have an active membership (primary residence) with Scenic Rivers Energy Cooperative.

- The applicant must be enrolling in their first semester of college in the Fall of 2025 and be either:
  - A senior in high school; or
  - A senior in a home-schooled program; or
  - A non-traditional student entering their freshman year in a post secondary accredited program
- 2. Applicant **must** be present at the SREC Annual Meeting held on April 12, 2025.
- 3. After successful completion of the student's first semester (Fall 2025) of post-secondary education AND receiving at least 12 college credits at a minimum "C" average for that semester, a \$1,000 check will be made payable to the school for second semester tuition. If the student fails to meet these qualifications, the scholarship will be awarded to the alternate if they have met all the same requirements.
- To apply, fill out the application and return it to the address below. Application must be received on or before April 7, 2025, to qualify. Applications may also be completed online at sre.coop/scholarship, through school counselors, or picked up at our Lancaster and Darlington offices.

Rebates are offered on a first-come, first-serve basis to current SREC members and are in place through December 31, 2025, or until funds are depleted by incentive or in total. In order to be eligible, rebate forms must be submitted to SREC within 3 months of the purchase or installation date. Additional terms and conditions may be found on rebate forms. Please read thoroughly before submitting.

Look for the Energy Star symbol to be eligible for most appliance rebates.

# ENERGY EFFICIENCY TIP OF THE MONTH

If you have a home office, look for opportunities to save energy in your workspace. Use ENERGY STAR\*-rated equipment, which consumes up to 50% less energy than standard models. Set equipment like printers and scanners to automatically switch to sleep or energy-saver mode when not in use. In addition to saving energy, the equipment will stay cooler, which will help extend its life. Another way to save energy in your home office is to use efficient lamps for task lighting. Replace any older bulbs with energy-saving LEDs.
