National Farm Safety Week September 15-21, 2019

Each year since 1944, the third week of September has been recognized as National Farm Safety & Health Week. This recognition has been an annual promotion initiated by the National Safety Council and has been proclaimed as such by each sitting U.S. President since Franklin D. Roosevelt signed the first document. The week continues to recognize the importance of protecting agriculture's most precious resource – its people

The 2019 theme “Shift Farm Safety into High Gear” is one that resonates and reminds us that it is everyone's responsibility to prioritize safety on the farm and the rural roadways of America. The 2017 data from the U.S. Bureau of Labor Statistics shows that the agricultural sector is still the most dangerous in America with 581 fatalities, which equals 23.0 deaths per 100,000 workers.

Scenic Rivers wants to remind everyone to take a moment to slow down and stay safe. We want our members and the communities we live in to be safe. Please practice good judgment when working around farm equipment or livestock, and when traveling our roadways near farm equipment.

Additionally, members may want to consider looking at their garage, shops or other work areas. Accidents can occur while repairs and maintenance tasks are being completed. Consider the following suggestions which could help to keep you safe.

- Organize your workshop so that everything has a designated place. Making sure items are secure and will not fall on anyone.
- Clean walkways to reduce trips and falls.
- Ensure any equipment you are working on is turned off, disconnected from the power source and that any moving parts have come to a complete stop. Engage any safety locks.
- Keep all guards and shields in place on power equipment.

- Use hand tools for their intended purposes.
- Equip your shop with Ground Fault Circuit Interrupters to help prevent electrical shock.
- Make sure your shop is well lit. If it is heated, be sure it is properly vented and that any flammable liquids are stored properly.
- Wear proper clothing to protect yourself when you are performing repairs.

As a cooperative, which is owned by our members, we care about the safety and well being of each member. We all live in our wonderful rural communities and we mutually benefit when everyone succeeds and is safe. We encourage our members to stay safe and to watch out for our farmers as we start the fall harvest season.



HARVEST SAFETY TIPS FOR FARMWORKERS

- **Maintain a 10-foot clearance** around all utility equipment in all directions.
- **Use a spotter and deployed flags** to maintain safe distances from power lines and other equipment when doing field work.
- **If your equipment makes contact with an energized or downed power line, contact us immediately** by phone and remain inside the vehicle until the power line is de-energized. In case of smoke or fire, exit the cab by making a solid jump out of the cab, without touching it at the same time, and hop away to safety.
- **Consider equipment and cargo extensions of your vehicle.** Lumber, hay, tree limbs, irrigation pipe and even bulk materials can conduct electricity, so keep them out of contact with electrical equipment.
